2023 Survey Report




The purpose of the Title IX Climate survey is both to determine the prevalence of sexual misconduct on campus and community knowledge of sexual misconduct policies and procedures. Participation in this survey was completely voluntary and collected no identifiable information to link individuals to responses, making it completely anonymous. The survey was sent to all 753 degree-seeking students enrolled in fall 2023 and received 103 responses. This amounts to a 14% response rate.





How do you identify?






















How confident are you in applying the definition of affirmative consent to real-life situations?



I know how to effectively intervene as an active bystander in a situation that has potential for sexual assault.







Q5.3 Per the Title IX and Sexual Misconduct Policy, affirmative consent is a knowing, voluntary, and mutual decision among all participants to engage in sexual activity. Consent can be given by words or actions, as long as those words or actions create clear permission regarding willingness to engage in the sexual activity. Silence or lack of resistance, in and of itself, does not demonstrate consent. Consent to any sexual act or prior consensual sexual activity does not necessarily constitute consent to any other sexual act. Consent is required regardless of whether the person initiating the act is under the influence of drugs or alcohol. Consent may be withdrawn at any time. When affirmative consent is withdrawn or can no longer be given, sexual activity must stop. A person is incapable of affirmative consent when they are: less than 17 years of age mentally disabled or incapacitated Consent cannot be given when it is the result of any coercion, intimidation, force, or threat of harm.
