

**MEMORANDUM OF UNDERSTANDING
BETWEEN
NEW YORK ONCOLOGY HEMATOLOGY
AND
MARIA COLLEGE**

December 1, 2021

I. General Statement of Purpose

This document establishes a formal Memorandum of Understanding between New York Oncology Hematology, and its affiliated employees, herein referred to as NYOH and Maria College, whereby Maria College will provide a tuition discount to qualified employees of NYOH and its affiliated employees, as well as their dependents, who meet Maria College entrance requirements for certain programs as described below.

II. Requirements and Terms

A. This Agreement applies to the following baccalaureate programs currently being offered by Maria College:

- i. Healthcare Management
- ii. Psychology
- iii. Liberal Arts

New programs must be specifically added in writing to become incorporated into this agreement.

B. NYOH employees, and their dependents who seek application, will provide all necessary application materials to Maria for consideration for program admission. Admission decisions are the sole responsibility of Maria College.

C. NYOH employees, and their dependents, as defined in this agreement, will meet all entrance requirements for the Maria College program under consideration.

D. Maria College will offer NYOH employees, as well as their dependents, as defined in this agreement, 40% discount off the published tuition rate for its bachelor's degree programs referenced above.

E. NYOH employees, as well as their dependents, would be responsible for all fees, textbooks, program materials and other costs of education.

F. For the purpose of this agreement, a NYOH employee will be defined as an individual employed by NYOH and working more than 24 hours per week. NYOH will provide Maria College with satisfactory evidence of employee eligibility.

G. For the purpose of this agreement, a NYOH employee dependent, will be someone meeting the IRS definition of dependent of a NYOH employee. Verification of dependency status may be verified upon request.

H. To qualify for the discount, the employee would need to complete the Free Application for Federal Student Aid (FAFSA) and the Maria college discount would be applied after any federal or state grants programs, but before student loans.


